This Player Agreement ("Agreement") is entered into by and between the parties identified below, governing participation in the Aledo Soccer Club Men's Semi-Pro program for the Fall 2026 season competing in UPSL Division 1. By signing this Agreement, the Player acknowledges and agrees to all terms and conditions set forth herein.

2. Term of Agreement

This Agreement shall be effective for the Fall 2026 UPSL Division 1 season:

This Agreement shall automatically expire at the conclusion of the season unless renewed in writing by both parties.

3. Player Commitments

The Player agrees to the following commitments for the duration of the season:

- Attend all scheduled training sessions, practices, and matches unless excused in advance by coaching staff.
- Arrive no less than forty-five (45) minutes prior to kickoff for all matches.
- Communicate promptly with coaching staff regarding any absence, injury, or scheduling conflict.
- Maintain a level of personal fitness appropriate for competitive semi-professional play.
- Adhere to the match day schedule, team protocols, warm-up routines, and any tactical directives issued by the coaching staff.

- Participate in team meetings, film sessions, and any other club-organized activities as required.
- On any Aledo Soccer Club game day, the Player is not authorized to play for any other team or club. Game days are reserved specifically and exclusively for Aledo Soccer Club. Failure to comply will result in disciplinary action, including a formal reprimand, and may result in suspension or removal from the roster.
- The Player is not guaranteed any match time. All playing time decisions are at the sole discretion of the coaching staff.

4. Professionalism & Conduct

The Player shall conduct themselves in a manner consistent with the values and standards of Aledo Soccer Club at all times:

- Represent ASC with integrity, respect, and professionalism both on and off the field.
- Refrain from any behavior that damages or could reasonably damage the Club's brand, reputation, or community standing.
- Maintain appropriate and respectful conduct on all social media platforms.
- Observe a zero-tolerance policy toward harassment, discrimination, abuse, or violent conduct of any kind.
- Demonstrate respect for all teammates, opponents, match officials, spectators, and club staff.
- Refrain from the use of illegal substances or excessive alcohol consumption within 24 hours of any match or training session.

5. Club Authority

The Player acknowledges and agrees to the following:

- The coaching staff and club leadership retain full and sole authority over team selection, lineup decisions, playing time allocation, formation, and tactical direction.
- Club leadership reserves the right to suspend or permanently remove any Player from the roster for violations of this Agreement, conduct unbecoming, or any behavior deemed detrimental to the team.
- The Player agrees to respect and comply with all decisions made by the coaching staff and club leadership without engaging in public dispute, argument, or dissent that undermines team cohesion.
- Disciplinary actions, including but not limited to suspension, fines, or removal from the squad, shall be at the sole discretion of club leadership.
- A direct red card, or two yellow cards in the same match resulting in a red card, carries an automatic one-game suspension, regardless of whether notice is received from the league or the Club.
- Red cards may carry a league-imposed fee. The Player agrees to reimburse the team for any league fee assessed because of the Player's direct red card or yellow card issued for dissent toward a referee.

6. Uniform & Equipment

The Player acknowledges and agrees to the following regarding club-issued equipment:

- The Club will provide the Player with an official match jersey and shorts at game time. Jerseys and shorts must be returned immediately after the game.
- The Player is responsible for maintaining team socks for both home and away matches. If sponsored socks are not used during the game, socks must be purchased prior to the match at a cost of \$10 per pair.
- The Player is solely responsible for the care, maintenance, and safekeeping of all club-issued equipment.
- Lost, stolen, or damaged equipment must be reported immediately to club staff.
- The Player shall be responsible for the replacement cost of any lost or damaged club-issued gear. Replacement costs will be communicated in advance.
- All club-issued equipment must be returned at the conclusion of the season or upon termination of this Agreement, whichever occurs first.

7. Social Media & Brand Representation

The Player agrees to the following regarding social media and public brand representation:

- Represent Aledo Soccer Club in a positive and professional manner across all social media platforms and public interactions.
- Tag and reference official ASC social media accounts (@AledoSoccerClub) in any match-related, training-related, or club-related posts.
- Refrain from posting any content that publicly criticizes, disparages, or undermines teammates, coaching staff, club leadership, or match officials.
- Avoid posting confidential team information including but not limited to tactical plans, lineup decisions, or internal communications.
- The Club reserves the right to request removal of any social media content deemed harmful to the organization.

8. Photo / Video Release & Media Consent

By signing this Agreement, the Player grants Aledo Soccer Club the following rights:

- The irrevocable right to capture, use, reproduce, and distribute photographs, video recordings, and audio recordings of the Player taken during training sessions, matches, events, and other club activities.
- The right to use the Player's name, likeness, image, and biographical information in ASC promotional materials, social media content, marketing campaigns, press releases, and media publications.
- This release applies to all media formats, including but not limited to print, digital, web, and broadcast.
- No additional compensation shall be owed to the Player for such use.

9. Health & Liability Waiver

The Player acknowledges and agrees to the following:

- The Player confirms that they are in good physical health and physically fit to participate in competitive semi-professional soccer, including training sessions and UPSL Division 1 matches.
- The Player assumes all risk of personal injury, illness, or property damage arising from or related to participation in ASC activities, including but not limited to training, matches, travel, and team events.
- Aledo Soccer Club, its directors, officers, coaches, staff, volunteers, and affiliates shall not be held liable for any injuries, losses, or damages sustained by the Player during the course of their participation.
- The Player is strongly encouraged to obtain and maintain personal health insurance coverage for the duration of the season.
- The Player agrees to disclose any pre-existing medical conditions, injuries, or medications to the coaching staff prior to participation.

10. Termination

This Agreement may be terminated under the following conditions:

- Either party may terminate this Agreement with a minimum of seven (7) days written notice to the other party.
- The Club reserves the right to terminate this Agreement immediately and without prior notice in the event of serious misconduct, conduct violations, repeated absence, or any behavior that the Club deems detrimental to the team or organization.
- Upon termination, the Player must return all club-issued equipment within seven (7) days.
- Termination of this Agreement does not release the Player from any outstanding financial obligations, including equipment replacement costs or applicable fines.

11. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas. Any disputes arising under or in connection with this Agreement shall be resolved in the courts of Parker County, Texas.

12. Agreement & Signatures

By signing below, the Player acknowledges that they have read, understand, and agree to be bound by all terms and conditions of this Agreement. The Player confirms that this Agreement has been entered into voluntarily and without coercion.
